Education for Change is rooted in our communities and committed to meaningful stakeholder engagement. Our students, staff, and families are an integral part of our strategic decision making and priorities process. Stakeholder feedback was collected through multiple ways to ensure that students, staff, and parents and guardians provided input on how to spend ESSER III funding. There were provisions made for stakeholder engagement to promote remote participation and address language accessibility. Staff participated in a series of input sessions where they reviewed community, cultural, academic and survey data from staff, students and families. Staff then engaged together to draw meaning from data observations and then gave input on spending and priorities. Students were provided a survey to collect their input. Parents and guardians engaged in the process during two family meeting events. Additionally, parents and staff completed a survey to gather feedback and direction on spending and priorities.

The trends that emerged from our stakeholder input directly informed the actions and expenditures outlined in this ESSER III plan. ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.
